By means of this NOTICE OF PRIVACY, the entities of the FRATELLI GROUP, inform you of the terms in which the "Personal Data" they

collect will be treated, for which, we recommend that you read carefully the following information:

1.- DEFINITIONS.

For purposes of this NOTICE OF PRIVACY, the terms indicated below shall have the meanings indicated in this document, whether written in the singular or in the plural:

- **1.1. "Personal Data":** Any information concerning an identified or identifiable natural person.
- **1.2. "Sensitive Personal Data":** Those "Personal Data" that affect the private sphere of the Owner, or whose improper use could give rise to any type of discrimination or entail a serious risk for the Holder.
